

Agent's Representative Course VIC Real Estate

In Victoria an agent's representative is employed by or acts for a licensed estate agent, and with written authority, can perform any of the legal functions of that estate agent.

To work as an agent's representative your employer is required to verify that you are eligible to be an agent's representative, and notify the Business Licensing Authority (BLA) when you start work. You do not need to be currently employed in the industry in order to undertake the course; many students do the course as a means of securing employment.
